CALL TO ORDER: President Jim Dorr called the meeting to order at 5:07pm.

RICK HOUSER – GALLERY HOMES – Rick Hauser from Gallery Homes introduced himself. The new track is called Gallery Links, 86 homes will be built. Mr. Hauser synopsized the three plot designs he will be building. His method is building backing out so new owners are not disturbed by the construction. Per city code, the new construction site must be fenced with locks. Mr. Elliott questioned the status on the age limit restriction for the new track? Mr. Hauser explained that the CC&R's will have a 55 and older restriction. He explained that he did research and majority of homeowners he interviewed would prefer to not have kids as neighbors. Homeowner Eddie Jones expressed his concerns with the fence and speed limit on Burnett. Mr. Hauser has been in communication with IPCCA, IPCA and the golf course to get construction gate access.

2015 Draft Budget – Mr. Elliott presented highlights of the 2015 Draft budget for IPCCA & the Lifestyle Center. <u>Motion to approve the 2015 draft budget for the Lifestyle Center as presented made by Mr. Elliott, seconded by Mr. Weise, motion carried.</u> <u>Motion to approve the 2015 draft budget for IPCCA as presented made by Mr. Elliott, seconded by Mrs. Botta, motion carried.</u>

Memo – Reserve Transfer - Wells Fargo Advisors Accounts - Mr. Elliott stated he would like to move \$500,000 from the operating account into the regular reserves account. <u>Motion to approve the transfer of \$500,000 from reserves into the regular operating account as recommended made by Mr. Wiese, seconded by Mrs. Botta, motion carried.</u>

Presidents Report - Mr. Dorr explained there was an Executive meeting prior to this meeting and reported that litigation, Gallery Homes, Vintage Landscape contract were discussed.

HOMEOWNER FORUM

Steve Sellinger – He is not happy with the appearance of the common area behind his home, specifically the golf course and the Greens HOA.

Don Berg - Stated that Matthau and Redford streets are worse than prior to the street slurry job.

A homeowner asked if there was a limit on water usage.
