## RE: IPCCA HOA IMPROVED PATROL AND OVERNIGHT PARKING RULE CHANGES

Dear Homeowner(s):

New street parking rules (Rules & Regulations Attached – Approved 9/11/17) will be in effect for IPCCA, starting 3/1/18. To summarize:

- Street parking is prohibited between 1:00 am and 6:00 am. Please park your vehicles in your garage or driveway during these hours.
- New tow/no parking signage will be installed prior to 3/1/18.
- Enforcement will be handled by Patrol Masters, a professional patrol and parking enforcement firm.
  - o Patrol Masters will leave citation notices on improperly parked vehicles and will keep complete records on all parking violations (time-stamped photos, vehicle type, license plate numbers, location, similar prior citations, etc.) and report all activities in violation to the IPCCA Management Company the following day, for Board follow up.
  - o If there are repeated violations, violators will be subject to hearings, fines or towing. Vehicles parked in prohibited or illegal areas, i.e. in front of fire hydrants, handicapped parking areas with no visible pass etc, will be towed without notice. Tow and impound fees are the responsibility of the vehicle owner.
- The IPCCA Rules provide for a limited number of street parking exceptions to address parking needs of temporary personal houseguests. Please call or email our Management Company, PPM, with inquiries on this (<a href="mailto:lettie@ppminternet.com">lettie@ppminternet.com</a> 760-325-9500). Over occupancy is not a valid reason to grant street parking exceptions.
- Homeowners are responsible for all actions of their tenants/renters.

Patrol Masters will also conduct checks on community pools and the Lifestyle Center during certain hours only. They will be available for general calls as well if you need them. You can call 877-648-0602 between the hours of 12:00am – 6:00am, 7 days a week. We hope this will provide some help in addressing overall safety concerns of our residents. In an emergency, always call 911.

Patrol Masters has an excellent relationship with Indio police and its staff is knowledgeable about patrol procedures. Their patrols will offset some of the additional expense IPCCA incurs during Festivals. Please note: Patrol Masters is employed by the IPCCA Board of Directors and their services are not available to residents in other HOAs.
